Question No. 1 & 2	Career Point University, Kota (Rajasthan) has been established by an Act of State Legislature of Rajasthan as a Private University and is empowered to award degrees as specified by the UGC under Section 22 of UGC Act, 1956 at its main campus in regular mode with the approval of Statutory bodies / Councils, wherever required.
	Career Point University, Kota (Rajasthan) is not authorized to open study centre/off campus centre beyond the territorial jurisdiction of the State as per the judgement of Hon'ble Supreme Court of India in the case of Prof. Yash Pal Vs State of Chhattisgarh. The University cannot open its centre(s) even within the State as per the provision of UGC (Establishment of and Maintenance of Standards in Private Universities) Regulations, 2003 without the approval of UGC. The UGC has not granted any approval to the University to open off-campus/study centre.
